Should defects occur after installation, and within the warranty period, they should be specifically described to a mwConnect representative. mwConnect shall correct any defects, at mwConnect’s option, by furnishing materials to repair or replace any products that may prove defective in materials or workmanship within the warranty period, or by extending a credit in the amount of the purchase price. This does not apply to: (1) damage caused by accident, abuse, mishandling, or dropping; (2) materials which have been subject to unauthorized repair; (3) materials not used in accordance with the instructions; (4) ordinary wear and tear; (5) malfunctions due to site conditions, including but not limited to: heavy tree coverage areas, any sources of radio interferences, building structures and constructions. mwConnect will be limited to the furnishing of new parts, free of charge, or extending credit for in the amount of the purchase price, in exchange for parts proven to be defective and does not include any other cost of removal or installation.

The standards and conditions of any test performed on any mwConnect products by the original purchaser, or by any third party acting on behalf of the original purchaser, shall be mutually agreed upon in writing and mwConnect shall be notified of, and may be represented at any such test.

This limited warranty is extended by mwConnect only to the original or first end user purchaser.

This limited warranty constitutes the sole and exclusive remedy of the purchase and the exclusive liability of mwConnect, and is in-lieu of any and all other warranties, expressed, implied, or statutory as to merchant ability, fitness for purpose sold, description, quality productiveness, or any other matter. No implied statutory warranty of merchant ability or fitness for a particular purpose shall apply beyond the aforementioned warranty period.
